

Re: Extension of Mutual Assistance Agreement



In accordance with Paragraph 6 of the Agreement, the undersigned hereby agree to further extend the Agreement for an additional 365 days by extending the Termination Date of the Agreement to March 19, 2024 (the “Extended Termination Date”). The Agreement shall continue in full force and effect through such Extended Termination Date. This instrument may be executed in multiple counterparts, each of which shall be considered an original.

IN WITNESS WHEREOF, each of the undersigned has caused this instrument to be signed in its name and behalf by its duly authorized representative as of the Effective Date.


