**Petition for License to Construct and Maintain Electric Lines
Over and Across Public Water in Goffstown, New Hampshire**

ORDER OF NOTICE

On July 22, 2022, Public Service Company of New Hampshire d/b/a Eversource Energy (Eversource, or the Company) filed a petition for a license to construct and maintain an existing 115 kV electric transmission line (the C196 Line) over and across public water in Goffstown. The petition and subsequent docket filings, other than any information for which confidential treatment is requested of or granted by the Department, will be posted to the Department's website at [Utility Crossings Over State Lands and Public Waters/NH Department of Energy](#).

The C196 Line was originally constructed in 1968. The public water crossing that is the subject of this petition was previously licensed in 2010 under DE 10-232 (Order No. 25,157) for the addition of optical ground wire (OPGW). In its current petition, Eversource proposes to: (1) replace existing wood Structures 143 and 144, with only Structure 143 being replaced with weathering steel equivalent; (2) license the replacement of the three-pole Structure 144 with a single pole engineered weathered steel structure which will be done after Structure 143 is completed (anticipated to commence in 2023); (3) replace the existing three 795 ACSR 36/1 conductors with 1272 ACSS 54/19 conductors; and (4) transfer the OPGW and static wires to the new poles. All replacement structures will be located within 10 feet of their current locations.

The C196 Line crosses public water of Glen Lake in Goffstown starting at Structure 143 immediately south from where the C196 Line crosses Elm Street in Goffstown, approximately 325 feet east from the entrance to the Glen Lake School and approximately 400 feet west from the Glen Lake Public Boat Ramp on Elm Street. The waterbody crossing extends south approximately 1,182 feet to Structure 144, where the line turns 90 degrees east into the Greggs Substation, located off Mast Road in Goffstown between the Goffstown Rail Trail Parking Lot and the Greggs Falls Dam/Hydroelectric station.

According to the petition, the structure replacement work will be accomplished within existing right-of-way easements, thereby mitigating impacts and concerns of property owners affected by the project. Eversource will obtain a New Hampshire Department of Environmental Services (NHDES) Statutory Permit by Notification (PBN) and Shoreland Permit Notification (PBN) for the work planned under this petition in relation to temporary impacts to wetlands and the shoreland buffer prior to the commencement of construction.

The Department will review the filing to assess the necessity of the requested license to meet the reasonable requirements of reliable service to the public, as required by RSA 371:17, and whether the license may be exercised without substantially affecting public rights in the identified public water in Goffstown, as required for approval under RSA 371:20. The applicant and any interested party has the right to have an attorney represent the party at the party's own expense.

Based upon the foregoing, it is hereby

ORDERED, that, the Department will hold a prehearing conference, pursuant to N.H. Admin. R., Puc 203.15, on August 17, 2022 at 1:00 p.m., at which any interested party may

provide its position with regard to the petition and any of the issues set forth in N.H. Admin. R., Puc 203.15; and it is


FURTHER ORDERED, that any interested party who wishes to participate in the proceeding shall file a written petition to intervene stating the interested party's basis for intervention consistent with RSA 541-A:32 and Puc 203.17 and specifying any objection the party has to the proposed crossings license. Petitions to Intervene shall be submitted to the Commissioner of the Department, with copies sent to the Petitioner that is seeking a license, no later than August 12, 2022. Failure to submit a Petition to Intervene at least three business days prior to the Prehearing Conference will constitute a waiver of the right to object to the Petition and the requested license; and it is

FURTHER ORDERED, that, immediately following the prehearing conference, Eversource, Department staff, and any intervening parties may hold a technical session to review the petition, as needed; and it is

FURTHER ORDERED, that, pursuant to N.H. Admin. R., Puc 203.12, Eversource shall notify all abutters to the proposed crossings by causing a copy of this order of notice to be sent, by any major delivery service that provides delivery confirmation, to the owners of all properties immediately adjacent and contiguous to the State land parcels that are subject to the proposed crossings. On or before August 12, 2022, Eversource shall file with the Department a list of all abutters so notified and copies of the return delivery confirmations. In addition, Eversource shall mail a copy of this order of notice to: (i) the Town Clerk of Goffstown, New Hampshire; (ii) the New Hampshire Attorney General; (iii) the New Hampshire Department of Environmental Services; (iv) the New Hampshire Department of Transportation; and (v) the
