Please be advised that as of June 17, 2023, Energy Rewards, LLC has registered with New Hampshire Secretary of State's office the assumed name Public Power. Public Power is a brand within our corporate family that has been operating for the last 15 years and is licensed as an electricity supplier in several other markets (<https://www.publicpowercompany.com>). 
