NOW, THEREFORE, upon notice from Obligee of Principal's non-performance of its duties as a New Hampshire CEPS, or Principal's fraud or other violations of the laws, rules, decisions, and orders applicable to Principal's CEPS registration, the Obligee shall provide notice to the Surety and to Principal, and the Surety shall render payment to the obligee within thirty (30) days of receipt of such notice, not to exceed the amount of this Bond. This Bond shall remain in full force and effect for the term set forth below unless terminated as provided below.

This Bond is subject to the following terms, limitations, and conditions:

- The term of this bond shall be for one year, commencing on 08/05/2021 and terminating on 08/05/2022, with a 6-month extended claims, draws, or demand period. This bond may be extended by continuation certificate for additional periods from the expiry date hereof.
   Notwithstanding the foregoing, this Bond may not be terminated prior to twelve (12) months after the date hereof.
- 2. That no proceeding in law or in equity may be brought under this Bond unless the same shall be commenced and process served prior to the expiration of six (6) months from the date of termination of this Bond.
- 3. The New Hampshire Public Utilities Commission may draw upon this financial security instrument if and when the Principal has failed to make required payment(s) and/or payment arrangements in accordance with the terms and conditions of an order issued by the New Hampshire Public Utilities Commission.
