Solicitation of Written Comment

February 23, 2024

Background:

Passage of the federal Inflation Reduction Act (IRA) created two residential rebate programs – the <u>Home Efficiency Rebates Program</u> and the <u>Home Electrification and Appliance Rebates Program</u>, collectively known as the Home Energy Rebate Program. The Home Energy Rebate Program allocates \$8.8 billion to states via formula grants. States must design rebate programs in accordance with federal guidance and apply to the United States Department of Energy (USDOE) for their formula grants.

The State of New Hampshire, through the New Hampshire Department of Energy (Department), is slated to receive \$34.952 million from the Home Efficiency Rebates Program and \$34.749 million from the Home Electrification and Appliance Rebates Program, totaling \$69.702 million in rebate funding for state residents.

The Home Energy Rebate Program is intended to benefit households by lowering the cost of undertaking meaningful home energy upgrades. These upgrades seek to lower consumer energy costs and improve the health and safety of homes. This funding also aims to increase the installation of efficient, clean energy equipment in underserved and underrepresented communities.

Request for Comments:

The Department is requesting written comment from homeowners, residential contractors, retailers, and other interested groups on topics that the Department should consider as it designs its Home Energy Rebate Program.

Examples of topics to address include, but are not limited to, ensuring simplicity for homeowners to access rebates, targeting underserved and underrepresented communities, and coordinating with qualified contractors to conduct home energy upgrades. These examples are intended as a guide, not as a limit to your comments.
