Power of Attorney

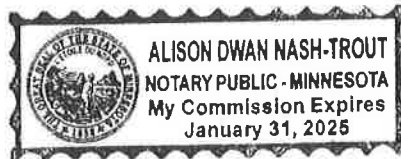
