
Dear Ms. Mee:

On October 23, 2023, Sunnova Energy Corporation submitted a request to be registered by the Department of Energy (Department) as an aggregator of RECs generated by customer-sited sources, pursuant to Puc 2507.01. Department staff have reviewed the request and determined that it meets the eligibility requirements under Puc 2507.01 and recommends approval effective October 23, 2023.

Therefore, the Department hereby approves and registers Sunnova Energy Corporation as an aggregator of customer-sited RECs effective October 23, 2023. The New Hampshire certification code for Sunnova Energy Corporation to act as an aggregator of RECs is NH-23-AGT-001; the aggregator number assigned by NEPOOL GIS to Sunnova Energy Corporation is 15439.
