Adjustment to Renewable Portfolio Standard 2024 Class III Requirement

ORDER OF NOTICE OF PUBLIC COMMENT HEARING

The Department of Energy (Department) has determined it appropriate to evaluate whether a sufficient supply of Class III (Existing Biomass/Methane) renewable energy certificates (RECs) will be available for New Hampshire electricity providers to comply with New Hampshire's Renewable Portfolio Standard (RPS) requirements under RSA chapter 362-F for the 2024 compliance year. The Department will consider whether an adjustment should be made to the Class III requirement for 2024. If the Department makes no change, the Class III RPS requirement will be 8.0 percent of retail sales for 2024.

Pursuant to statute, the Department is authorized to adjust Class III RPS requirements as necessary and consistent with the purposes of RSA chapter 362-F. The law allows the Department, after notice and hearing, to modify Class III requirements, "such that the requirements are equal to an amount between 85 percent and 95 percent of the reasonably expected potential annual output of available eligible sources after taking into account demand from similar programs in other states." RSA 362-F:4, VI.

The Department is aware of reduced production from a number of Class III certified biomass facilities during the 2024 calendar year. Combined with uncertain demand and market dynamics on the regional scale, these reductions call into question the ability of electricity providers to procure sufficient New Hampshire Class III RECs to satisfy the Class III RPS requirement for compliance year 2024.

Based on that market uncertainty, the Department has determined that a potential adjustment to the Class III RPS requirement for the 2024 compliance year should be considered. Accordingly, the Department will hold a virtual public comment hearing on December 19, 2024, at 1:00 pm to gather information regarding the 2024 annual electric generation output of certified Class III eligible sources, the regional market demand for the RECs produced by those sources, and the corresponding availability of New Hampshire Class III RECs to meet the Class III RPS requirement for compliance year 2024. The Department encourages interested parties to submit written comments to the Department by close of business on December 16, 2024 to Proceedings@energy.nh.gov.

Based on consistent feedback received annually from stakeholders seeking a timelier decision regarding adjustment to the Class III requirement the Department requests stakeholder input on possible market implications should the Department set a minimum threshold of not less than 0.5% obligation with potential upward adjustment only after review and consideration of data received for quarter three.

This order of notice raises, *inter alia*, issues related to whether it is appropriate and reasonable for the Department to adjust RPS Class III requirements for compliance year 2024, pursuant to RSA 362-F:4, VI, and, if so, how that adjustment should be calculated.


Based upon the foregoing, it is hereby
