Dear Ms. Duron:

On March 11, 2024, Summer Energy informed the New Department of Energy (“DOE” or “Department”) of its initial notification of withdrawal as a competitive electric supplier pursuant to Puc 2004.15. On May 10, 2024, Summer Energy informed the DOE that it was withdrawing its registration as a competitive electric power supplier, pursuant to Puc 2003.08, and requested the return of its financial security instrument. The Department has determined that you have met the requirements of the 2000 rules.

Enclosed please find your original line of credit #6076-30 filed with the Public Utilities Commission as requested. As of the date of this letter you are no longer a competitive electric supplier registered with the New Hampshire Department of Energy and are not authorized to provide electricity in New Hampshire.


